c) PURPOSE, LEGAL BASES AND MANDATORY OR OPTIONAL NATURE OF THE PROCESSING

Legal basis:

d) RECIPIENTS

e) TRANSFERS

f) DATA STORAGE

All personal data provided will be processed in compliance with the principles of lawfulness, correctness, relevance and proportionality, only with the methods, including computer and telematic methods, strictly necessary to pursue the purposes described above. In any case, personal data will be kept for a period of time not exceeding that strictly necessary to achieve the purposes indicated. Personal data for which conservation is not necessary or for which conservation is not required by current legislation, in relation to the purposes indicated, will be deleted or transformed into anonymous form. It should be noted that the information systems used to manage the information collected are configured, from the outset, in such a way as to minimize the use of data.
