- Entry to the facility is allowed only to members and exclusively for 'admitted' activities.
  - The entry of guests of customers with booking of duration is allowed on the basis of the conditions set out in the welcome card in the paragraph "Methods of carrying out seasonal and daily bookings - Entrances and guests".
  - The reservation for the entrance of guests can be made in presence of the member, but also through the use of the web application; the payment of the reservation **for guest entry can be made directly online**, or directly at the premises of the facility.
  - The fees for daily hospitality will be communicated with a special daily service card.
  - The submission of an online booking request implies the user's express acceptance of the general conditions prepared by the structure for the provision of the service requested by the user, considered an integral part of the booking. Reservations are permitted for persons over 18 years of age. Reservations by minors under the age of 18 are permitted only with the prior authorization of a parent or person exercising parental responsibility. The cancellation or modification of the reserved slot must be done through the app. In any case, the evaluation of the reception margins of daily guests remains in the exclusive determination of the structure which will establish the opportunity from time to time due to the monthly fluctuation in the number of members. The management reserves the right to charge the amount due for the reservation made and not canceled by 24.00 on the day before the reservation. In any case, failure to use the booking does not result in a refund of the amount paid.
  - The seasonal promo rate will be applied to all registered users according to the terms and conditions specified in the seaside tourist contract.
  - Children up to 3 years are exempt. Those who have a birthday during the booked period, moving from one price range to another, will pay the amount due in proportion to the relative price ranges.
  - The mini club is active from Tuesday to Sunday; in September it is active only on Saturdays and Sundays. The kayak service is active from Tuesday to Sunday from 15th June to the end of the season.
- All tourist-bathing activities and services may be suspended for superior safety reasons to safeguard the safety and integrity of people and things; thus they may also be susceptible to changes in the hours and in the methods of use and explanation of the service.

The gastronomic, recreational and sporting events are organized in activities in calendars that will be communicated from time to time by the reception office according to the established schedule.
